Dear NOCCA St. Tammany/Tangipahoa Parish Parents:

NOCCA is pleased to announce that Northshore Charter will again provide incredible resource to assist parents with access to NOCCA's half-day instructional program, Monday – Friday.

Northshore Charter, with its contracted company First Student Bus Company, will organize and coordinate round-trip bus transportation for NOCCA ½ day afternoon students. Students will be brought from Covington, Fontainebleau and Mandeville High Schools midday and brought back to Mandeville High or Books-a-Million in Covington each weekday late afternoon.

The fee associated with this service will be set by Northshore Charter and will be determined by the number of students who register. Seating is limited, so please mail the registration form to Northshore Charter along with the **non-refundable \$50 deposit by May 14, 2010** to secure your child's seat. The **non-refundable** expected balance of **\$1,250** must be paid in full on **Saturday, July 31** at the home of Craig and Rhonda Huval located at 87 Walnut Place, Covington, LA 70433. No late payments will be accepted.

- **All students who ride the bus must pay all fees in full regardless if they plan on riding the bus one-way or a few days a week to NOCCA. Discounted or prorated rates are non-negotiable.**

The fee for the round-trip service is expected to be **\$1,300** per student for the 2010-11 school year and is **non-refundable**. This fee is based on forty passenger ridership. The exact amount due will be emailed to all families who have completed the registration and \$50 deposit by May 14. Special tags will be distributed to each student registered for the bus once his/her fee is paid in full. These tags **must** be shown **daily** to the bus driver in order to gain access on the bus as all students who ride the bus must be paid in full.

The convenience of the consistent and reliable bus service includes daily pick-up of students in an air-conditioned bus with curbside service to NOCCA, arriving promptly for afternoon instruction with daily return service to St. Tammany Parish.

NOCCA Updates

- The NOCCA Institute will **not** be able to provide financial aid to families who may need support with this bus transportation cost. It is NOCCA's hope that this early communication will help families begin to save the needed finances in time for the July 31 deadline.
- NOCCA expects requests for this bus to exceed current seating allotments. NOCCA recommends families to forward the needed \$50 deposit by May 14 for priority confirmation.
- Families may charge their non-refundable balance of \$1,250 with credit card by calling NOCCA at 504.940.2836 but a \$65 fee (charged by our processing company) will be added to the total charge.
